### TERMS & CONDITIONS:

- Budgeting amounts are based on an estimate of fuel consumption over a 12 month period of time, and an average price based on the previous year. \* If customers use more gallons than estimated or we have significant pricing increases, your account may be subjected to a mid-year increase. This increase can be broken down and added into your remaining months or a one-time payment to bring your account current. Selecting one of the two options will prevent any disruption in service.
- Preferred payment method is check, money order or credit card on file.
- We offer Automatic monthly payments by processing your credit card on file on the 15<sup>th</sup> of each month. Please fill-out Credit Card Authorization if this is your preferred payment method.
- Budget Plans must be in conjunction with Automatic Delivery. This contract does not include any maintenance or service. Our Service Plans are optional; however strongly recommended.
- Budget participation can be cancelled at any time by the customer or Brunelli Energy. We reserve the right to cancel if payment is delinquent at the time of your scheduled delivery and we are not responsible for fuel level.
- Payments are due on the 15<sup>th</sup> of each month; August - June. Any payments not received by the 30<sup>th</sup> will be considered delinquent. Customer understands and agrees to pay interest at the rate of 1.5 % per month (18% annually) on delinquent budget accounts that have an outstanding balance. This would include payment of all costs of collection, including but not limited to court costs, marshal fees, and a reasonable attorney’s fee in the event that customer’s account is delinquent.
- All sales are final. No Refunds. Any remaining credit balances can be used for oil delivery or service work.
- Underestimating your gallons will only negate the purpose of the budget program and possibly require additional payments during the season. Better to overestimate!!!
- **TANKS MUST BE FULL PRIOR TO FIRST DELIVERY ON BUDGET PLAN** (Contact office to arrange).

**\*The estimated price per gallon is based on the preceding year’s average daily market price. Monthly payments will be disbursed over an eleven-month period. The twelfth month (July) will be used to adjust credit balances or outstanding balances.**
